About NSBW



National Small Business Week is the premier educational outreach event for small business owners in the United States. In 2023, National Small Business Week generated **more than 27,000 mentions and more than 87,000 engagements** on Twitter, Facebook, Instagram, and other social media platforms.

More than 20,000 small business owners registered to participate in the 2023 NSBW Virtual Summit, over 7,600 attended with 31,801 online seminar views.

The volume of stories reached 4K during NSBW, with a total coverage of 9.9K from January 2023. The overall potential reach was 14B, with an advertising value of \$130M.



The sessions from the virtual summit are available on SCORE.org, making the content available to small business owners for months.

This added benefit will lead to increased views and engagement well beyond the live event.




National Small Business Week Virtual Summit
